NOTE 1 - NATURE OF ORGANIZATION

The Dalai Lama Trust (the "Trust") was founded in 2009 by His Holiness the 14th Dalai Lama to support the activities of individuals or institutions working for the welfare of the Tibetan people, the advancement of the culture and heritage of the ancient civilization of Tibet, and the promotion of the deep rooted values associated with it.

The Trust's primary source of revenue is contributions.

The Dalai Lama Trust is exempt from federal income tax as a not-for-profit organization under Section 501(c)(3) of the Internal Revenue Code. The Trust was organized in February 2009 and started operations in April 2009.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting - The financial statements are prepared on the accrual basis of accounting.

FASB Accounting Standards Codification - In July 2009, the FASB released FASB Accounting Standards Codification (ASC) as the single source of authoritative nongovernmental U.S. Generally Accepted Accounting Principles (GAAP). The Codification is effective for interim and annual periods ending after September 15, 2009. All existing accounting standards documents are superseded as described in FASB Statement No. 168, *The FASB Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles*. All other accounting literature not included in the Codification is nonauthoritative.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Unrestricted net assets - Unrestricted net assets include funds having no restrictions as to use or purpose imposed by donors.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Contributions - Unconditional contributions, including promises to give cash and other assets, are reported at fair value at the date the contribution is received. The gifts are reported as either temporarily or permanently restricted support if they are received with donor stipulations that limit the use of the donated assets. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, temporarily restricted net assets are reclassified as unrestricted net assets and reported in the statement of activities as net assets released from restrictions.

Contribution of royalties - His Holiness has contributed all royalties received on publications sold in the United States.

Functional allocation - The costs of providing the organization's programs and other activities have been summarized on a functional basis. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

Uncertainty in income taxes - The Trust adopted the provision pertaining to uncertain tax positions (ASC Topic 740) and has determined that there are no material uncertain tax positions that require recognition or disclosure in the financial statements. Since this is the initial filing year, there are no open tax years except the current year that is subject to examination by applicable tax authorities.

Fund raising - Fund raising is performed by board members and other volunteers. As a result, no costs have been reflected on the accompanying financial statements.

Subsequent events - Subsequent events have been evaluated through August 9, 2010, which is the date the financial statements were available to be issued.

NOTE 3 - CONTRIBUTION FROM TIBET FUND

In January 2010, the Tibet Fund contributed the accumulation of contributed royalties amounting to \$1,277,688 to The Dalai Lama Trust.

NOTE 4 - CONCENTRATIONS OF CREDIT RISK

Financial instruments which potentially subject the Trust to a concentration of credit risk are cash accounts with major financial institutions in excess of FDIC insurance limits.

The Trust receives 43 percent of its support from contributions of royalties.
